Duncan G. Sinclair Lectureship in Health Services and Policy Research

CHSPR was again proud to join with the School of Policy Studies to co-host the 2012-13 Sinclair Lecture and the Queen's Health Services and Policy Research Day. The primary goal of the Sinclair Lectureship is to promote and enable opportunities for stimulating discussion and knowledge exchange that address the most pressing health services and policy issues.

This year, Jeffrey Simpson was our distinguished lecturer. Mr. Simpson has been the Globe and Mail's national affairs columnist for more than 25 years. An Officer of the Order of Canada, he is an award-winning author of nine books whose work has won all three of Canada's leading literary prizes - the Governor-General's award for non-fiction book writing, the National Magazine Award for political writing, and the National Newspaper Award for column writing (twice), as well as the Hyman Solomon Award for excellence in public policy journalism.

Mr. Simpson's latest book, "Chronic Condition: Why Canada's Health Care System Needs to be Dragged into the 21st Century", examines how Canadian health care is ill-adapted to an aging population, and explores how to tackle this growing crisis. Mr. Simpson regularly contributes to television and radio programs and is a sought-after speaker at major conferences in Canada and abroad.
