## 6. <u>Dean's Report</u>

#### a) Events of September 11, 2001

Dean D. Walker referred to the tragic events of Sept. 11, 2001 in New York and Washington. These events will affect how we care for patients, teach and do research at Queen's. Dean Walker acknowledged that the students were the first to come forward with offers of help.

## b) Faculty of Health Sciences Goals for the Year

Dean D. Walker stated that the Goals for the coming year were circulated to all faculty electronically. He welcomed comments.

## c) Budget

The three year funding plan is that there will not be any increase in transfer payments from the Provincial Government. The inflation factor for the university is 4 to 5%, thus there will be a budget shortfall of 4 to 5%. There are two options change revenue or change expenditures. There is need to find a solution.

# d) Advancement

The Queen's campaign is proceeding well. The target is \$200 Million and we have achieved \$190 Million to date. The Faculty of Health Sciences has raised \$34 Million for various projects. The funding for the Cancer Research Institute is essentially in place.

#### e) Education Awards

Dean Walker reported that a mechanism is being developed to recognize the contribution of faculty to the educational activities of the Faculty of Health Sciences.

## 7. Research Report

Dr. J. Brien reported on the CIHR competition announced in June. There were 30 applications for operating grants submitted and 9 were successful. This is slightly below the national average. With respect to the strategic training initiatives from CIHR, six letters of intent were submitted and four have been invited to submit a full proposal.

The Research Advisory Committee is developing guidelines for a mentorship program where junior faculty would be mentored by senior faculty. This committee is also developing a peer review process for grants before they are submitted. These issues will be brought to board for comment and approval.

She asked for the support of the other two schools as they move in this new direction.

Students may be nominated for this award by their peers. Nominations should be submitted to the Chair of the Physical Therapy Program by December 1<sup>st</sup>.
