Task Force Terms of Reference



Purpose

The Faculty of Health Sciences (FHS) has identified the strategic objective of expanding its capacity and capability to conduct research that is encompassed by Canadian Institutes of Health Research (CIHR) Pillars 3 and 4 (i.e. health services, policy and population health research). Guided by this objective, the purpose of the Task Force is to recommend:

- The optimal organizational design for the FHS units that are currently engaged in or support Pillars 3 and 4 research
- Strategies and actions that will enable enhancement of the scholarly productivity of involved faculty and their generation of high-impact research.

Consideration was also given to the roles of the two hospital based research institutes and to the roles of investigators not associated with the current centres who were identified in the Environmental scan

Workshop Summary: Opportunities



- Focus on Vulnerable Populations and Social Determinants of Health
- Moving into interventional HSR/KT work, not just descriptive
- Complex chronic disease care; linking ICES@Queen's to other data
- Models of community based care and support
- SE LHIN as an HSR laboratory

Recommendation Highlights



- 16 recommendations detailed in the full report including:
 - Create a broad based Research Institute incorporating CHSPR, ICES Queen's, HSR components of PRN, QJBI and a number of currently unaffiliated researchers/emerging groups.
 - Other centres to remain in their current configurations.
 - Establish interim executive and management committees from current leadership at existing centres, plus representation from the School of Rehabilitation Therapy and involvement of leadership from closely related centres. Dr. M. Green to serve as interim director/chair of executive committee.
 - Draft formal proposal for submission to senate/search for director to follow

• That Faculty Board approve the proposal to establish a Senate approved Faculty Institute for Health Services and Policy Research
