The Chair reported that a call for nominations to fill the vacancies on Board committees has gone out to Department Heads.

## 5. Dean's Report

# • Strategic Planning

The Dean presented a DRAFT power point presentation on the strategic planning exercise to date for the Faculty of Health Sciences. The Dean explained that there would be a vision and values for the Faculty of Health Sciences along with three distinct missions, one for each School. He reported that the planning is in its final stages. He reported that over 1500 people have been consulted and a retreat was held last month in the new School of Medicine building for input. The Strategic Plan will consist of four pillars (Research, Education, partnerships and patient focus). A steering committee has been created and the final plan will be ready in three to four weeks.

## 6. Nominating and Procedures Committee

• Motion: "On the Recommendation from the School of Rehabilitation Therapy that Board approves the appointment

of T. Krupa as a Senator for the Faculty of Health Sciences for the term July 1, 2012 to June 30, 2015."

On behalf of the Nominating and Procedures Committee and on the recommendation of the School of Rehabilitation Therapy it was moved by D. Edgar and seconded by E. Culham that <u>Dr.</u> <u>Teresa Krupa be elected as the School of</u> <u>Rehabilitation Therapy Senator for the Faculty of</u> <u>Health Sciences.</u>

• Motion: "On the direction of University Senate the number of Faculty Senators is to be increased form four to five elected members as per the revised Terms of Reference."

D. Edgar reported with the addition of a Graduate Senator, the Faculty of Health Science's Senator representation has increased from four to five. There will now be a Basic, Clinical, Nursing, Rehabilitation Therapy and Graduate Senator.

Therefore, it was moved by D. Edgar and Seconded by E. Culham that the delegation of (4) senators to Senate be changed to (5) senators with the addition of a Graduate Senator as per the Faculty of Health Sciences Terms of Reference.

• Motion: "That Board approves the creation of a Faculty Board Executive as per the Terms of Reference."

D. Edgar reported that a creation of a Faculty Board Executive was discussed at this forum in May of 2011 and a Notice-of-Motion was brought back to the November 2011 Board. D. Edgar distributed the

Terms of Reference and put forward the above motion. During discussion it was asked that the FHSGC be added to #1.

It was moved by D. Edgar and Seconded by E. Dagnone that Faculty Board approves the creation of a Faculty Board Executive as per the amended Terms of Reference.

### Motion: "That Board approves the revisions to Faculty Board's Terms of Reference."

D. Edgar reported with the creation of the above Faculty Board Executive some revisions were needed in the wording of the Faculty Board's Terms of Reference. D. Edgar pointed out that there will be one scheduled meeting a year in the month of February but if necessary the Secretary in consultation with the Chair could call a special meeting of Faculty Board members to deal with substantive or specific issue(s). During discussion it was noted that the February meeting could be comprised of major reports from the Dean, Vice-Dean's and or Committee Chairs. So with the amended grammar errors on page 4,

It was moved by D. Edgar and seconded by J. Medves that the amended revisions to the Faculty of Health Sciences Faculty Board Terms of Reference by approved by Faculty Board.
