# 1. <u>Call to Order</u>

The Chair called the meeting to order at 5:00 p.m. with approximately 20 members present.

# 3. Approval of Minutes of Last Meeting – April 7, 2010

#### 4. <u>Announcements</u>

- a) D. Walker reported to Faculty Board that Marianne Lamb has finished her term as Chair of Faculty Board and thanked her for her service to faculty matters.
- b) D. Walker reported that Dr. Susan Cole has been appointed Deputy Provost at Queen's University. Congratulations!
- c) D. Walker read a tribute to Dr. Charles Sorbie, Professor and past Head of the Department of Surgery who died prematurely as a result of a skiing accident this past March. Dr. Walker noted Dr. Sorbie's stellar career as a clinician and equally as a scholar in multiple ways. Dr. Sorbie will be greatly missed by Queen's and his family but initiatives are underway so his legacy and his name will continue. Condolences to his family on behalf of Faculty Board. A copy of the tribute in more detail will be filed with the minutes and sent to the Senate Office to be read at a meeting of Senate and forwarded to the Dr. Sorbie's family.

## 5. <u>Dean's Report</u>

• D. Walker reported that funds have been directed to the Learn Initiative in the Lakeridge Health Education and Research Network

Centre in Oshawa. It was capital funds given to us by the Ministry to help in our expansion in our Family Medicine program. This helps with our partnership with Queen's and the region through the department of Family Medicine.
