

# **Policy on Privacy and Confidentiality**

## I. Purpose

The purpose of this document is to articulate the OPDES policies on privacy regarding collection of personal information

## II. Applicable Queen's University Policies

Queen's University is governed by FIPPA, PHIPA and applicable Queen's University policies. OPDES abides by their current forms and rulings.

#### **III. OPDES Policies and Applications**

- i. In compliance with the above policies, OPDES collects personal information such as e-mail addresses, profession, home address etc. about our participants for the purposes of:
  - 1) Enabling online education
  - 2) Enabling notification of future educational related events. Participants must choose to both subscribe to all newsletter communications and have an option to unsubscribe as outlined and governed by relevant anti-spam legislation. There is an exception to this law in cases where the audience is internal to Queen's or has attended a germane program in the last two years.
  - 3) Enabling registration and contact details for payment follow-up should there be rejected payment(s)
  - 4) Evaluation and continuous improvement of programs and program planning
  - 5) Customization of programs for audiences
- ii. OPDES will protect and retain personal contact information for seven (7) years in a secure manner unless individual participants request otherwise.
- iii. All information collected for research or scholarship activities is governed by the two-research ethics board at Queen's University: General Research Ethics Board and Health Sciences and Affiliated Teaching Hospitals Research Ethics Board
