### **1. Call to Order and Announcements**

The meeting was called to order at 5:00 p.m. with approximately 30 members present by Dr. W. Racz.

#### **a) Nominating Committee's nomination of W. Racz as Chair of Faculty Board**

Wigle reported that three Faculty members were nominated for Chair of Faculty Board and after discussion the Nominating Committee put forward a motion that W. Racz become the next Chair of Faculty Board based on his experience and knowledge of Faculty Board rules. W. Racz will take this position until the end of June, 2004 when he retires.

### **4. Introduction of New Faculty**

**Dr. S. Olney, Director of the School of Rehabilitation Therapy introduced:**

#### Dr. Rosemary Lysaght

Dr. Rosemary Lysaght is a member of the Occupational Therapy faculty. Dr. Lysaght completed her Occupational Therapy professional program at the University of Western Ontario, her MSc at the University of North Texas where she specialized in work adjustment in Rehabilitation Counseling and her PhD. from Ohio State University with specialization in program evaluation/adult education and organizational behavior. She has recently served on OT faculty at the University of Utah, University of Finland, Ohio; and Dalhousie and is now back in Canada. She has also practiced as an Occupational Therapist for twenty years and both her clinical and research interests focus on work participation in people with disabilities

especially in the area of industrial rehab ergonomics, vocational training, rehabilitation technologies, and cross cultural service provision. She has also done research on educational methods in these educational technologies and worked as a program evaluation consultant in addition to teaching. She served on a national panel in the US to create standard protocol for public transportation eligibility determination services for people with disabilities under the American Disabilities Act.

**Dr. J. Wilson, Head of the Department of Urology introduced:**

**Dr. Darren Beiko**

Dr. Darren Beiko is a native of Alberta born in Peace River, educated in Quebec. He graduated from the University of Ottawa with his undergraduate medical certificate when he came to Queen's University to do his Residency. He did a two-year fellowship at the University of Western Ontario and research in minimally invasive/urologic surgery. His research is in clinical Urology and minimal access surgery. During his time as a resident he was recognized as a highly skilled teacher.

**Dr. W. Mackillop, Head of Community Health & Epidemiology introduced:**

**Dr. Patti Groome**

Dr. Patti Groome is a holder of a Canada Research Chair in cancer care evaluation. Dr. Groome completed her PhD at McGill in the early 1990's and through out the 1990's she has been a Ministry of Health Career Scientist in the Radiation Oncology Research Unit based at the Kingston General Hospital. Her programs are currently funded by NCIC and CIHR. Dr. Groome who was formally a member of the Department of Oncology and an adjunct member to Community Health & Epidemiology and has now become a full time member of Community Health & Epidemiology.

**Dr. A. Ferguson, Head of the Department of Physiology introduced:**

**Dr. Michael Dorris**

Dr. Michael Dorris did his undergraduate degree at Queen's University in the Life Science Program. He then did a PhD degree with Dr. Munoz here in the Physiology Department. His PhD Thesis won the Governor General's Medal as the best PhD Thesis. Since then he went to work in a lab at the Centre of Neuroscience at New York University where he under took a Postdoctoral fellowship for a period of three years. Dr. Dorris's primary interests are in the neuro-control of decision-making and he has been awarded a Canada Research Chair in this field. Mike is part of a joint recruitment with Neuroscience studies.

**Dr. Luis Melo**

Dr. Luis Melo is working in the Cardiac Circulatory Respiratory Group (CCR) which he is jointly recruited with the Department of Physiology. He undertook his BSc program at York University in Toronto and also his PhD at the University of Toronto with Al Saunder. He

then went to Harvard University and completed his Postdoctoral Fellowship there. He then became an Assistant Professor at the University of Saskatoon. The Department of Physiology was able to recruit him to Queen's where he is now being nominated for a Canada Research Tier II Chair.

**Dr. John MacLeod**

Dr. John MacLeod is a cross recruitment with Physiology and Gastrointestinal Diseases. He has a very strong research background. He did his BSc at Western, his PhD at McGill University and following he did a postdoctoral fellowship working with the World Health Organization in Dhakkar Bangladesh. More recently he spent some time working at the Brigham-Young Women's Hospital at Harvard Medical School learning Molecular Biology. His main interests are in the area of mucosal transport in the GI systems. John has been awarded a Canada Research Tier II Chair.

Dr. W. Racz welcomed all the new members of Faculty to Queen's University and to Faculty Board and encouraged them to participate in the deliberations of Board.

**9. Report from the Schools**

**a) School of Nursing**

M. Lamb reported that the School of Nursing had a mini review of their new undergraduate program. The program is in its third year and it had to be reviewed prior to the graduating students writing their registration exams. The review was done in November and it was a successful review and M. Lamb thanked everyone who participated in the review process.

**b) School of Rehabilitation Therapy**

S. Olney reported that they had begun their Masters of Science Occupational and Physical Therapy Program for one year for practicing clinicians and next year the professional program will be entirely at the Masters level. She is pleased to report that the applications are very good and reaching very high levels of candidates applying. They have two accreditations being prepared in Occupational and Physical Therapy.

**c) School of Medicine**

J. Fisher reported that the School of Medicine is undergoing enrolment expansion of 100 students in the first year class. The curriculum is undergoing a review by S. Verma and D. Holland. This will assess the undergraduate medical curriculum and examine all phases of the curriculum and institute any changes that are deemed necessary. Dr. Ludwin continues to draft the Research Strategic Plan and it will be brought forward to Council in the near future. The Life Science program continues to be the most popular undergraduate program at Queen's in the Honours Science Degree and this is strengthening the budget.

W. Racz reported that the Curriculum Review process will be reported at the next meeting in order to keep Faculty Board informed on how the curriculum review is progressing.
