6. Dean's Report

(a) Budget

Dr. C. Chapler reported on behalf of Dean D. Walker. The budget reduction for 2001-2002, were 2% for inflation, 1.25% for progress through the ranks, and 0.5% to meet the demands of the Collective Agreement. In addition the Basic Science departments were assessed on additional 0.25% for strategic investment, for a total of 4% for most departments and 4.25% for the Basic Science departments. The implications are that these budget reductions will have serious implications for the departments and their programs.

On a more positive note, the CIHR will soon announce the establishment of training grants.
