Applications are invited for a Term Adjunct to teach 50% of a virtual course entitled
HPE 802: Health Professions Education Curriculum & Design

Course Level: Graduate

Location: onQ and Zoom

Anticipated Enrolment: 25

Period of Appointment: September 1 – December 31, 2024

The Master of Health Professions Education is a program in which every course is team-taught by a health professional and an educationalist PhD.

Course Description:

The purpose of this course is to introduce a range of theories and approaches to curriculum development, such as competency-based education and outcomes-based education. Sessions will be literature informed but activity and discussion-based with an expectation of a high degree of collaboration and participation. This course highlights the importance of curricular alignment including connections between course outcomes/goals, delivery of instruction, and the assessment and evaluation of learning. The course is designed to encourage reflection on the importance of designing and developing positive learning environments with a focus on how curricular design promotes learning in health education settings. The course has been organized in such a way as to balance theory and practice and to support both conceptual and skill development.

Qualifications for the Appointment:

A doctorate in education or relevant field with at least two years of post-doctoral experience relevant to the field of instruction.

As this course is being offered in an online format, successful candidates will also:

- Have regular access to high speed internet and a computer that meets current specifications
- Be willing to team-teach
- Take an active role in delivering the course through Zoom and onQ
- Communicate regularly with students
- Be open to learning how to use new technologies in order to be effective in the virtual environment
- Be available Thursdays from 4:30 – 6:30 PM EST Canada for six (6) Zoom sessions throughout term (September – December)
- Be willing to provide students with timely and constructive feedback on onQ
- Be comfortable with working in a partnership in the delivery of the course

Application Materials:

Individuals interested in applying for this term adjunct teaching position should submit an application by May 14, 2024. The application shall include:

- A cover letter
- A complete and current curriculum vitae (CV)
- The names of two referees who may be contacted
- Any other materials the applicant wishes to submit (such as a teaching dossier)
