### **Term Adjunct Teaching Position Available 2024 Summer Term**

Applications are invited for a Term Adjunct to teach 50% of a virtual course entitled  
**HPE 804: Health Professions: Teaching & Learning in Collaborative Practice**

Course Level: Graduate

Location: onQ and Zoom

Anticipated Enrolment: 18

Period of Appointment: May 1 – August 31, 2024

The Master of Health Professions Education is a program in which every course is team-taught by a health professional and an educationalist PhD.

#### **Course Description:**

To ensure the delivery of optimal care to patients, a collaborative practice approach to teaching, learning, and communication needs to be adopted across health teams. This course will explore best practices for facilitating learning, strategies for delivery of content, and ways of conducting assessments and evaluations to learners from varied health backgrounds. This course will explore common challenges such as communication, leadership style, self-awareness, mode of delivery, and dealing with difficult learners.

#### **Qualifications for the Appointment:**

A doctorate in education or relevant field with at least two years of post-doctoral experience relevant to the field of instruction.

As this course is being offered in an online format, successful candidates will also:

- Have regular access to high-speed internet and a computer that meets current specifications
- Be willing to team-teach
- Take an active role in delivering the course through Zoom and onQ
- Communicate regularly with students
- Be open to learning how to use new technologies in order to be effective in the virtual environment
- Be available Tuesdays from 4:30 – 6:30 PM ET Canada for six (6) Zoom sessions throughout term (May - June)
- Be willing to provide students with timely and constructive feedback on onQ
- Be comfortable with working in a partnership in the delivery of the course

#### **Application Materials:**

Individuals interested in applying for this term adjunct teaching position should submit an application by January 25, 2024. The application shall include:

- A cover letter
- A complete and current curriculum vitae (CV)
- The names of two referees who may be contacted
- Any other materials the applicant wishes to submit (such as a teaching dossier)
